With the acquisition of Minerva, active in the field of textile pigments with a strong foreign presence, the Group becomes one of the leading suppliers of chemical products for the Italian textile industry and strengthens its competitive ability in world markets, thanks also to the presence of affiliated sites in Europe, Turkey and South Africa.

Achitex Minerva S.p.A. was created on 1 January 2010 through the transfer of the industrial branch of Achitex Srl to Minerva S.p.A.

The definition and implementation of a “Quality and Environment Policy” are the keystones of the strategy implemented by the Achitex Minerva S.p.A. General Management, which, with the aim of ensuring the full satisfaction of its Customers, Associates and Consumers, has developed a Quality and Environment Management System in accordance with the following standards:
